Industry challenge

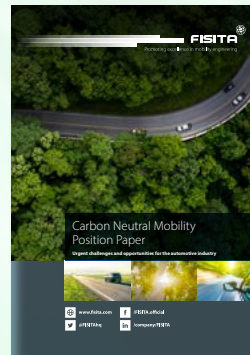
The environmental impact that results from the ever-increasing demand for transportation.

Industry challenge

FISITA know the Safety of mobility is an essential part of sustainability; however, we have not yet met the target or vision of zero traffic fatalities.

FISITA response

FISITA created the FISITA Intelligent Safety Working Group which produced the 2020 FISITA ISWG and published the first White Paper on the Safety Aspects of Assisted and Automated Driving. This publication informed us how we could progress our work in this area through a second White Paper, this time focusing on the safety of Electric Vehicles (EV).

Industry challenge

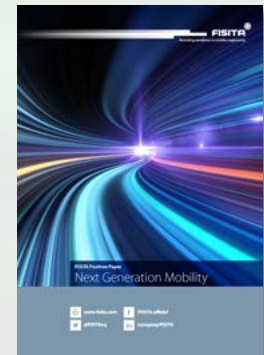
In the path to decarbonization there can't be one aspect; FISITA set out to acknowledge the challenges, opportunities and potential solutions around this topic.

In September 2023 FISITA hosted the Technology of Mobility Conference and Exhibition; three-days full of networking, knowledge share and thought leadership, with the FISITA World Congress, FISITA World Mobility Summit, FISITA Intelligent Safety Conference Europe and EuroBrake hosting 2,164 attendees and 103 exhibitors, delivering 393 presentations, 80 technical papers and 12 panel sessions.
